With reference to the letter 1st cited, I wish to inform that this office has examined your request for sanction of recognition to the Sports Tamil Nadu Roll Ball Association based on the documents furnished by you and recognition hereby accorded provisionally to Sports Tamil Nadu Roll Ball Association, subject to approval of Executive Committee of SDAT and subject to outcome of petition against the recognition with following terms and conditions.

1. This recognition means entrusting a major role to the Sports Tamil Nadu Roll Ball Association for the development of the Roll Ball game.
2. The various guidelines issued by the Government / SDAT, from time to time, including the age and tenure criteria for holding the elective office of the Association shall be scrupulously followed.
3. The Sports Tamil Nadu Roll Ball Association shall give advance notice to SDAT at least two months before any change in its constitution. The copy of the existing Constitution and the proposed changes should invariably be sent along with the notice.
4. The Sports Tamil Nadu Roll Ball Association must maintain its accounts in proper manner. The Account books shall always be

- open to inspection by authorized representatives of the SDAT/ Government.
5. The accounts of The Sports Tamil Nadu Roll Ball Association must be audited by a practicing Chartered Accountant. Audited statement of account should be sent to the SDAT.
 6. The Association must scrupulously abide by the guidelines of the SDAT issued from time to time, for the conduct of National Championships drawing of the advance calendar for hosting National Championships, players' grievance system in the management of the Association etc.
 7. The Recognition would be reviewed in case MOA (Memorandum of Association) of the Sports Tamil Nadu Roll Ball Association or its other practices come into conflict with the Guidelines of SDAT amended from time to time.
 8. Government observers shall be invited for all State and National level competitions. The Competitions shall be held for Men & Women at all levels i.e. National, State, and District at senior, Junior and Sub-Junior level.
 9. It is mandatory to display the recognition number and validity date in all areas wherever the name or logo or any other identity of SDAT is used by the Association. This includes stationeries, brochures, hoardings, etc., and does not include sports kits.
 11. Duly invited SDAT as Observer for the state-level selection process and coaching camp for all National and international events that are eligible for the high cash incentive scheme of SDAT (as per the calendar of events approved by SDAT)
 12. Duly invited SDAT as Observer for the competitions conducted by the association, for which any form of grant is claimed by the association.
 13. Duly conducted the Annual General Meeting of the association and Elections of the association as per the constitution of the association and as per applicable rules and regulations in place.
 14. Duly invited SDAT as Observer for all such AGM and Elections, conducted on any date after this recognition.
 15. The NSF shall have a valid recognition on the date of application. In case of Olympic Sports, the valid recognition of IOA is also necessary.

All the requests for financial assistance and clearance of proposals must be submitted in the prescribed manner. Assistance may be provided to the Association subject to the availability of funds, submission of the relevant documents, fulfilment of the terms & conditions/ guidelines, etc., as may be prescribed from time to time, by the SDAT.
