1. **Name** : The name of the Association shall be **SPORTS TAMILNADU ROLL BALL ASSOCIATION**
2. **Secretarial Office** : The registered office of the association shall be the permanent address of the Secretary Door No.54. EB Colony, Gandhigram Post, Athur Taluk, Dindigul-624302
3. **Jurisdiction** : The area of operation of the association shall be Dindigul District.
4. **DEFINITION:**
 - a. Association shall mean **SPORTS TAMILNADU ROLL BALL ASSOCIATION**
 - b. General Body shall mean the General Body of **SPORTS TAMILNADU ROLL BALL ASSOCIATION.**
 - c. Committee shall mean the Executive Committee of the Association.
 - d. Club shall mean a club, institution, department, school and university.
 - e. Year shall mean the financial year.
 - f. District shall mean Dindigul District.
 - g. State shall mean Tamilnadu.
5. **AIMS & OBJECTIVES :**

The aims and objectives of the Association shall be

Associated member means a veteran and reputed sportsman associated in the association.

8. GENERAL COUNCIL :

It shall consist of the following members.

- a. All Associated members
- b. One member from each affiliated Member Units for a term of Four years.

9. EXECUTIVE COMMITTEE:

It shall of 7 members including:

President	-	One

Joint Secretary	-	Two
Treasurer	-	One

The other members shall be:

1. One member from each affiliated Member Units
2. One Associated member nominated by the President / Secretary

Note : The life of the executive Committee shall synchronize with the life of the General Body.

10. OFFICE BEARERS OF THE ASSOCIATIONS

11. VACANCIES:

Vacancies of the office bearers shall be filled in by the President & Secretary and will be confirmed in the next General Body meeting.

12. SELECTION COMMITTEE:

The selection committee shall consist of 7 members including the President, Secretary and the Selection Committee Chairman. The other members will be nominated by the President / Secretary in consent to the General Body.

13. FUNCTIONS OF THE GENERAL BODY

The functions of the General Council shall be

- a) To examine and pass the audited accounts within one month from the closure of the financial year.
- b) To approve and sanction the yearly budget which will be submitted by the Treasurer.
- c) To lay down the general policy and guide-lines for the improvement of the sport in the State
- d) To pass orders on unserviceable stores and
- e) To elect office bearers

14. POWER AND FUNCTION OF THE EXECUTIVE COMMITTEE :

Subject to policy direction and general control of the council, the powers and functions of the Executive Body shall be:

- i. To carry on day to day business of the association
- ii. To perform such functions as may be specially delegated by the council
- iii. To consider applications for grant of affiliations to clubs and members.
- iv. To prepare necessary statements of the unserviceable articles and get these written off by the General Council.

- v. To appoint sub-committees as may be required from time to time.
- vi. To take necessary action against players misconduct.
- vii. To withdraw affiliation from such clubs as may not be abiding by the rules and regulations of the association.
- viii. To sanction grants for various activities within the budgetary provisions.

15. POWERS AND DUTIES OF THE OFFICE BEARERS

The powers of the office bearers shall be as under:

PRESIDENT

- a. Will preside over the General Council, Executive Committee meetings of the association
- b. Shall accord permission for the conduct of a local tournament. He may, however, consult the Secretary, if necessary.
- c. Shall be empowered to incur expenditure of Rs.25,000/- at a time.
- d. May suspend a member of Association for unbecoming behavior, pending enquiries.
- e. May delegate his powers in writing to some other office bearers or a member of the Association during his absence from HQs.
- f. Will be empowered to call meeting of the Executive Committee and the General Council at his discretion.

VICE PRESIDENT

- a. Shall be responsible for organization promotion and development of the game in the province.
- b. Shall act as Chairman of the Provincial Wing of the Association.
- c. Shall incur an expenditure as per directions of the Executive Committee from time to time.

GENERAL SECRETARY

- a. Shall be responsible for carrying out the orders and instructions of the SPORTS TAMILNADU ROLL BALL ASSOCIATION.
- b. Shall attend day to day business of the Association.
- c. Shall maintain record of all correspondence and the Minute book of all proceedings of the meetings of the Association.
- d. Shall have control over the office establishment of the Association.
- e. Shall call meetings of the General Council.
- f. Shall prepare Annual Report of the activities of the Association and place it before the Executive Committee and the General Council for consideration.
- g. Shall operate upon the funds, jointly with the Treasurer of the Association.
- h. Shall organize activities of the Association at District Level and coordinate the same at the Provincial Level.
- i. Shall be empowered to incur expenditure of Rs. 10,000/- at a time.
- j. Shall take any decision on behalf of with the consultation of Chairman and President.

TREASURER

- a) Shall keep an impress money of Rs.5000/- in hand for day to day business of the Association.
- b) Shall maintain accounts of the Association.
- c) Shall submit annual budget for the approval of the Executive Committee and the General Council.
- d) Shall get the account of the Association audited by the Chartered Accountant to be appointed by the Executive Committee.
- e) Shall receive grants, donations, contributions against proper receipts and deposit the same in any Bank in the name of the Association.

JOINT SECRETARIES

- a. Shall act as Secretary for his own province.
- b. Shall organize activity in the province with the permission of the Vice President of his wing in consultation with the Executive Committee.

2. MEETINGS

- a. The General Body meeting of the Association shall be held once a year at Tamilnadu or at any where in Tamilnadu within Six Months from the Closure of the financial Year i.e. before 30th September.
- b. Executive Committee meeting shall be held from time to time according to the need with 21 days notice at least.
- c. Special meetings of the General Council may be convened by the President if 1/3rd of members make written request to the President.

Note: Notice of the meeting shall be issued by the Secretary, Twenty one days earlier to the date of the meeting along with the agenda.

17. QUORUM

Quorum for the council meeting shall be 2/3rd of the total membership and Quorum for the Executive meeting shall be majority

18. AMENDMENT

No amendment shall be made in the constitution unless it is carried by a two third Majority of the General Council

19. SUBSCRIPTION

Annual subscription fee for Member Units / Clubs / Schools / Colleges / District Institutions shall be Rs.2,000/- and affiliation fee shall be Rs. 3,000/-

20. MEMBERSHIP FEE

- a. Affiliation Fee Rs.5,000/-
- b. Associated members Rs. 100/- (per month)

Affiliated district association and associated members who fail to clear the annual fee by the end of the month following 31st March each year shall forfeit the right of vote.

21. ELECTION OF OFFICE BEARERS

The General Body shall elect all the office bearers.

22. TENURE OF MEMBERSHIP

- d. The General Council shall remain in office for Three years. At the end of 3rd year, a fresh election will be held.
 - e. An office bearer shall be re-elected for more than any consecutive terms if the general council accepts unanimously.
3. In case of resignation or leaving his office for any reason the President may nominate any person among the members to act against that post till confirmation by the General Council.

23. DISPUTES

In case of any dispute between factions as to who are the legally and constitutionally elected office bearers of the association, the matter will be referred to the appropriate body as per the guide-lines of Sports Tamilnadu Roll ball Association for Men & Women

24. DISSOLUTION

A Registered Society finds any difficulty to run the Society under Tamil Nadu Societies Registration Act, section 39, it shall be dissolved under section 41, apart from the liabilities of the dissolved society, remaining assets shall be transferred to another Society having the same objects for this it requires a special resolution.

25. SUPPLY OF BYE-LAWS

A copy of Bye-Laws will be distributed on request against the payment of Rs.1/- per copy.

26. BANK ACCOUNTS

The Bank Account shall be opened in any of the Nationalized Bank jointly by the President/ Secretary and Treasurer Jointly. The operation of accounts Shall be jointly by any two of the President, Secretary and Treasurer.

27. CASH BALANCE IN HAND

The Maximum cash balance shall be not more than Rs.5,000/-(Rupees five Thousand only) in hand.

28. FINANCIAL YEAR

1. The financial year shall be from 1st April to 31st March of every succeeding year
2. Reports to be filed with the registrar.
3. Books to be maintained.

29. ELECTION

1. The Office Bearers will be Elected once in Four Years by the General Body Members.
2. The Election Notice Should be circulated before 30 days of the Election date
3. The Election should be conducted by an Election Officer nominated by the General Body.


